Action Alert Supports Amending Section 420 Transfer Rule

NRLN members were asked on March 1 to respond to a very important Action Alert to both of their U.S. Senators because the House passed the COVID-19 economic stimulus legislation through the budget reconciliation process and sent it to the Senate.

The COVID-19 bill provided a unique opportunity to urge Senators to include in the legislation an amendment to the Employee Retirement Income Security Act (ERISA) and Internal Revenue Code (IRC) Section 420 that would help protect healthcare and life insurance benefits for millions of retirees with a single employer defined benefit pension.

NRLN has been lobbying to reduce the Section 420 surplus transfer limits from 120% and 125% to 110% for "de minimis" transfers of not more than 1.75% of plan assets for a single or multi-year transfer and the surplus be used to fund healthcare and life insurance benefits. A single employer pension plan funded at 110% provides an ample cushion for market volatility.

Although the amendment to the Section 420 Transfer Rule was not included in the COVID-19 legislation, NRLN President Bill Kadereit said, "everything we do enhances our chances of succeeding to get this legislation passed later in 2021."

Action Alert Urges Preventing Cuts to Medicare Funding

In a March 22 Action Alert NRLN members were asked to urge their U.S. Senator to vote for a House bill to prevent cuts to Medicare funding.

On March 19, the U.S. House of Representatives passed H.R.1868 and sent to the U.S. Senate a bill to avert \$36 billion in funding cuts to Medicare next year. The bill would exempt the recently enacted \$1.9 trillion American Rescue Plan COVID-19 economic stimulus legislation from deficit-reducing requirements under the 2010 "pay-as-you-go" law.

The bill also provides a moratorium until the end of the year on a 2% Medicare payment cut caused by a federal budged sequestration under the Budget Control Act of 2011.

NRLN President Bill Kadereit wrote in his March 21 FORUM message that responses to NRLN Action Alerts were important when members of Congress were working on the recently enacted American Rescue Plan, the

NRLN members' response to the February 13 Action Alert helped Senators and Representatives reach the decision that the Time to Rescue United States Trust (TRUST) Act should be removed from the COVID-19 relief bill.

Letters in response to our March 1 Action Alert attempted to convince Senators to include in the COVID-19 bill an amendment to the Employee Retirement Income Security Act (ERISA) and Internal Revenue Code (IRC) Section 420. The amendment would help protect healthcare and life insurance benefits for millions of retirees with a single employer defined benefit pension. Although the amendment was not added to the bill, the NRLN will continue to work on having it included in pension legislation this year.

NRLN Legislative Committees' Work

The NRLN's Legislative Affairs Committee (LAC) composed of Judy Stenberg, Chairwoman, Deb Morrissett, Joe Mazzei, Al Duscher and Bob Martina submitted the following bills for the Legislative Action Planning Committee (LAPC) to consider for action during its March 1 conference call.

- **H.R. 153, Protecting Consumers Access to Generic Drugs Act**, would prohibit the practice of "pay-for-delay," in which brand name drug companies compensate generic drug makers to delay the entry of generic drugs into the market.
