Bill shared real-time happenings and current roadblocks he is experiencing in Washington, DC. The NRLN NM Chapter is going to hold another call and we would really appreciate your participation.

The NRLN NM Grassroots Organization is holding a conference call on Monday, **April 4th, 2016 at 7:00 PM, Mountain Daylight Time**, to discuss current NRLN events and the latest NRLN Grassroots plans for 2016. As you know, 2016 is an election year and we need to make those individuals who plan to run for election aware of your needs. This will be a very informal discussion about what you can do to make them aware, and what to ask them to do. Some of the topics for discussion will be:

- Potential negative consequences to retirees when pension plans are merged.**
- Need for the Pension Guaranty Corporation (PBGC) to change the Annual Funding Notices (AFN) that are sent out each year listing the current funding of your pension plans.**
- NRLN commended the 51 U.S. Representatives who signed a letter urging the Director of the National Institutes of Health (NIH) to utilize "existing statutory authority to respond to the soaring cost of pharmaceuticals."**
- What the new Speaker of the House has stated about Medicare and Social Security and what actions the NRLN to protect these earned benefits.**
- Open discussion is welcomed.**
