# The NRLN Clarion Call ... NRLN's Bed Rock Issues Advocated By Bill Kadereit, NRLN President

A group of 24 dedicated representatives from six retiree associations, three NRLN chapters, three invited State/Congressional District Leaders and the NRLN staff advocated in meetings on Capitol Hill the bed rock of our Legislative Agenda—pension income security and reduction of healthcare costs, particularly the price gouging on prescription drugs.

This was during the NRLN's 2016 Leadership Conference in Washington, DC, Feb. 8 – 10. Twenty-three of the attendees had previously met with members of Congress and/or their staffs in past years. They are veterans at advocating for legislation important to retirement security. Two of the three State/Congressional District Leaders who were invited because

they are constituents of members of Congress in leadership positions or on committees important to retirees, were with us for the first time but performed like experienced advocates.

#### The Issues Advocated on Capitol Hill

- Pass Safe and Affordable Drugs from Canada Act (S.122 and H.R. 2228).
- Medicare Prescription Drug Price Negotiations Act (S. 31 and H.R. 3061).
- Pension Plan Protection:
  - Need for legislation and/or regulatory rules for pension plan mergers.
  - Need for legislation and/or regulatory rules for more disclosures in pension plan Annual Funding Notices (AFNs).

#### 'Troupers' from Retiree Associations and Chapters

The 24 real "troupers" were representatives from AT&T Ameritech/SBC Retirees (AASBCR), Detroit Edison Alliance of Retirees (DEAR), Engineering Retirees Society (ERS – Boeing), Lucent Retirees Organization (LRO), National Chrysler Retirement Organization (NCRO) and TelCo Retirees Association (TelCo). The chapters represented included General Motors, Utah and Washington State.

In addition to Faye advocating the NRLN's legislative issues, the meetings with staff members for Senators Alexander and Corker provide me with an opportunity to request support from the Senators for retirees of the Tennessee Valley Authority who recently formed the NRLN TVA Retirees Chapter. The TVA retirees' pension plan is only funded at 53% and has a \$6 billion funding shortfall. The TVA's pension plan does not have the protection of the Employee Retirement Income Security Act (ERISA) or the Pension Benefits Guaranty Corporation. Nor is their pension plan part of the Federal Employees Retirement System.

Don Begley , Conroe, TX, a constituent of Representative Kevin Brady (TX-08) who is chairman of the powerful House Ways and Means Committee, met with Representative Brady's Legislative Assistant and the Legislative Assistant for Texas Senator Ted Cruz, a presidential candidate. Since Don and I are fellow Texans, I joined Don for a meeting with Health Care Issues Legislative Assistant for Texas Senator Cornyn, a member of the Finance and Judiciary Committees. We were disappointed to learn that Senator Cornyn does not support reducing the cost of prescription drugs through the importation of lower cost, safe medicines from Canada or allowing Medicare to negotiate for the price of prescription drugs.

Representative Ryan, who at that time was Chairman of the House Ways and Means Committee. As one might expect, there are now even more demands on the Congressman's time and Bill had a brief meeting with one of his staff members. Bill also had meetings with staff members for both Wisconsin Senators, Ron Johnson and Tammy Baldwin, a member of the Health, Education, Labor and Pensions Committee.

#### **Opening Session of Conference**

Our conference opened at 2:00 p.m. Feb. 8, at the Liaison Capitol Hill Hotel. I opened the agenda with comments on the NRLN's financial status and its

future direction. Marta Bascom, NRLN and AREF Executive Director, and Michael Calabrese, NRLN and AREF Legal Counsel, provided an update on the status of the American Retirees Education Foundation (AREF), a nonprofit, tax-exempt organization, created to extend the research and education reach of the NRLN and to enable NRLN to sharpen its focus on lobbying for the passage of federal legislation and regulations that benefit retirees.

Calabrese reported that he has written a 22-page document describing the type of research the AREF plans to do educate policy makers and the public about retiree pension and health care benefits earned through decades of hard work are being steadily cut back and put at risk due to a variety of corporate financial maneuvers, as well as by outdated or shortsighted federal government policies. He has also written a prototype for an inquiry letter that is being used to seek out foundations that may be interested in providing grants to financially support research on retirement income security and retiree health care, particularly the need to reduce the cost of prescription drugs.

The AREF update was followed by Bascom providing an outlook on retirement-related issues in Congress. She said much will depend on what bills the Republican-led House and Senate will attempt to get passed that will help the party retain its majority in both chambers during this election year and will possibly assist a Republican in winning the Presidential election.

Bascom noted there are 13 bills in Congress that would help reduce the cost of prescription drugs and in some cases also save billions for Medicare. She explained to attendees the importance of advocating in their Capitol Hill meetings the need for legislation that would require a pension plan sponsor to submit its proposal to merge two or more pension plans to the Pension Benefits Guaranty Corporation, Department of Labor and the Internal Revenue Service for possible approval before taking action. Currently, pension plan sponsors only notify the federal government after plans are merged.

Bascom also explained the need for legislation to provide more transparency on the status of pension plan funding in the Annual Funding Notice (AFN) sent to pension plan participants. Currently, AFNs provided my many companies give retirees a false sense of income security by the information provided.

Guest Speaker Addresses Rx Issues
Our guest speaker was Nicholas Uehlecke, Professional Staff Member of the House majority Ways &

Means Committee. He acknowledged that the price of prescription drugs is rapidly escalating. He said the belief of many Republicans on the Ways & Means Committee is that they do not want to tell pharmaceutical companies what can be charged for prescription drugs. He said the preference is to make

more drugs available and the prices would start to fall.

#### **NRLN Committees Deal with Bills**

Judy Stenberg, NRLN Vice President – Pacific Region, Chair of LAC and LAPC member; Deb Morrissett, Director, National Chrysler Retirement Organization and LAC member made a presentation on the roles of Legislative Affairs Committee (LAC) and Legislative Action Priorities Committee (LAPC) related to analysis of retirement-related bills in the House and Senate. The LAC has checked 8,367 bills and reviewed indepth 118 bills introduced in the 114th session of Congress (2015 and 2016). The LAPC has elected to actively support 65 of those bills (see bills at <a href="http://www.congressweb.com/nrln/bills">http://www.congressweb.com/nrln/bills</a>). An additional 23 bills are considered low priority for the NRLN, or have been superseded by another bill of higher relationship to the NRLN legislative agenda. They presented handouts on the 31 prescription drug bills that the NRLN is supporting.

Ed Beltram, NRLN Vice President – Communications, presented important NRLN Grassroots issues on behalf of Bob Martina, NRLN Vice – President – Grassroots. Seventy-seven percent of the 435 Congressional Districts have one or more CD leaders. There are 558 state and CD leaders. Beltram asked the leaders of the retiree associations and chapter to follow up NRLN Action Alerts with personal messages to their grassroots advocates to urge them to email the NRLN's sample letters to their members of Congress.

#### **Meeting with Staffers of House Committees**

Eleven attendees had their first meeting on Capitol Hill on Tuesday morning with three staff members of the House Ways and Means Committee and Education and Work Force Committee. Attendees were NRLN staff members and retiree association and chapter leaders whose members have a defined benefit pension plan. I explained to the committees' staff members that the meetings had been held in December 2015 with the Department of Treasury and the Pension Benefits Guaranty Corporation in an effort to gain protections for retirees from pension losses due to pension plan mergers where a well-funded plan's assets are confiscated and added to at-risk plans to create one plan that is poorly funded. While the Treasury and PBGC officials said they understand the retirees' concerns about pension plan administrators' having unilateral authority to merge plans, it is generally believed that legislation would be needed to protect retirees.

The focus of our meeting with the committee staff members was an initial step toward advocating the need

to introduce and pass legislation to provide specific protections for pension plan participants when pension plans are being merged.

#### **Two Days of Capitol Hill Appointments**

Following this meeting, the NRLN staff members and retiree association and chapter leaders headed for other appointments on Capitol Hill that continued throughout Tuesday and much of Wednesday. They participated in more than three dozen meetings with members of Congress and/or their staffs.

# A View From Washington

## The NRLN Continues its Mission on Capitol Hill To Protect Pension Assets for Retirees

The NRLN has spent 13 years defending retirees from the onslaught of schemes by pension plan administrators which result in placing pension assets which rightfully belong to plan participants at great risk. Through the hard work of retirees who volunteer their time to talk to their members of Congress, the NRLN has recently made Washington, DC aware of these seemingly benign actions by plan administrators that often escape their attention.

Your NRLN grassroots network continues to fight for retirees today as we demonstrate to members of Congress and federal agencies the risk that emerges when pension plan administrators merge plans that are managed under their umbrella despite their very different funding levels.

#### **Chrysler and Qwest Retirees Know First-Hand**

Retirees from Chrysler and Qwest (and formerly USWest) have experienced this first-hand. Fiat Chrysler and CenturyLink have each merged multiple plans which were funded at different levels, some being well-funded while others funded at much lower levels. The benefit for the companies and for those in the poorly-funded plans is obvious as the better funded plan assets helped raise the levels for the rest without requiring top-off contributions from the company. The risk falls solely on those participants who had long been in a plan that was better funded. From one day to the next, those participants find their funding levels significantly lower simply because of the merger with lower funded plans under the sponsorship of the same company.

#### **Retirees' Concerns Well-Founded**

The concerns for retirees are well-founded. First, the lower funding level of the new plan could mean a much lower return from the Pension Benefits Guaranty Corporation (PBGC) should the plan be subject to a

distress termination. Second, these mergers are not subject to any review prior to action by the plan administrator. The administrator merely has to notify the IRS after the fact. Risks for the plan's participants – and the PBGC if it is a large plan – are not considered as they are in cases when companies themselves are merging. Therefore, there is no analysis about the risk to the plan participants in the better funded plan. Third, the Employee Retirement Income Security Act (ERISA) was intended to protect plan participants and does not raise scenarios where pension assets can be placed at risk due to intra-plan mergers. The participants of the healthier plan should not be subjected to the fate of those from a less-healthy plan and likely from a company alien to their own. By remaining silent in such cases, Congress' actions are antithetical to the goals of ERISA.

#### NRLN Working to Find Solutions

The NRLN is continuing to meet with federal agencies and members of Congress to raise these concerns to find solutions to stop this unnecessary risk-taking by plan sponsors. The practice of intra-plan mergers is not a new one, but it has been an understated predator which should be seen by policymakers in the clear light of day. Our grassroots network is working to make this happen.

# **AREF Income Security Committee Will Sharpen NRLN's Focus**

The American Retirees Education Foundation (AREF), a nonprofit education foundation to expand the research and educational reach of the NRLN, has formed an Income Security Committee.

"The role of the committee will be to provide resources for policy research and educational activities, including the creation and updating of whitepapers and fact sheets, as well as briefings, events, videos and other educational material aimed at retirees, retiree advocates and policymakers, said Bill Kadereit, AREF President, who also serves as NRLN President.

He said research done by the committee would enable the NRLN to sharpen its focus as an organization lobbying for the passage of federal legislation and regulations that benefit retirees.

"Committee members will be responsible for determining and recommending what publications the AREF and NRLN should produce that cover income security topics, including Social Security, Bascom said. "Michael Calabrese will be the principal drafter of material the ISC agrees would be useful.

"To be clear, lobbying done by the NRLN will be kept separate from AREF projects funded with tax-deductible donations, Kadereit said. "The dividing line between AREF and NRLN is actual lobbying of members of Congress, or their staff, by NRLN about a bill introduced and pending before Congress. AREF can recommend policy reforms – just as NRLN whitepapers have done – but AREF resources cannot be used to lobby for passage of those bills.

"As individuals, each of us may continue to meet with and educate members of Congress and their staffs on behalf of NRLN's proposals to create policy change (the law). Lobbying restrictions also do not apply at all to meetings concerning regulation with executive branch agencies, such as the Department of Labor, Department of Treasury and Pension Benefits Guaranty Corporation.
